The largest section is containing in Folio SL32764F - A long strip of 8.72 acres, this parcel of land offers road frontage on both side and there is excellent potential to divide the plot into 2 large sites of over 4 acres per site (subject to planning permission).

Additional to the above land, there are two further smaller sections with SL32764F offering circa 0.19 acre & SL32764F offering circa 0.14 acres. Both parcels of land have road access on one side with private sea access on the other side with direct and immediate sea views. Planning to build a residential building on these lands would seem unlikely due to the size and position beside the sea.

The location of these lands is second to none with Castletown Bay Beach just minutes away. The horseshoe-shaped bay offers sandy stretches and pebbly coves and is very popular for water sports. The bay offers excellent windsurfing conditions while also being a popular spot for walking / running and is adored by locals and tourists alike.
